

Official Rules – American Remodeling Enterprises Inc. Monthly Customer Review Contest

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE THE CHANCES OF WINNING.

These Official Rules (“Rules”) govern the American Remodeling Enterprises Inc. Monthly Customer Review Contest (“Contest”) sponsored by American Remodeling Enterprises Inc., 57 St. James St., Schuylkill Haven, PA 17972 (“Sponsor”).

1. Eligibility

The Contest is open only to:

- Legal residents of the Commonwealth of Pennsylvania;
- Individuals who are 18 years of age or older at the time of entry; and
- Customers who have previously completed a remodeling project with American Remodeling Enterprises Inc. (“Eligible Customers”).

Employees, contractors, officers, and directors of the Sponsor, its subsidiaries, affiliates, and their immediate family members (spouse, parent, child, sibling) and persons living in the same household are not eligible to enter or win.

2. Contest Period

The Contest runs on a monthly basis. Each monthly Contest period begins at 12:00 AM Eastern Time on the first calendar day of the month and ends at 11:59 PM Eastern Time on the last calendar day of the same month (the “Contest Period”).

Sponsor reserves the right to modify or cancel the Contest at any time, with or without prior notice.

3. How to Enter

An eligible customer may earn **up to two (2) entries per Contest Period** using the approved methods below.

- **1 entry** is earned by submitting a qualifying review.
- **2 entries** are earned when the review includes original photos of your completed project.

Entry Methods

1. **Google Review – Schuylkill Haven, PA:**
Submit a review on the American Remodeling Enterprises Schuylkill Haven Google Business page.
2. **Google Review – York, PA:**
Submit a review on the American Remodeling Enterprises York Google Business page.
3. **Google Review – Selinsgrove, PA:**
Submit a review on the American Remodeling Enterprises Selinsgrove Google Business page.
4. **Facebook Post:**
Post a review of your completed remodeling project and **tag** the official American Remodeling Enterprises Facebook page.

All entries must be submitted **during the Contest Period**.
Entries submitted before or after the Contest Period will not be eligible.

Entry Requirements

- **Photos** must be original, unaltered, and clearly show a project completed by **American Remodeling Enterprises Inc.**
- **Reviews** must relate to a current or past project completed by American Remodeling Enterprises Inc.
- Any **Facebook post** must be public and remain publicly viewable throughout the Contest Period and the winner verification process.
- The **Sponsor** may verify the authenticity of any review or post.
Fraudulent or ineligible entries will be disqualified.

4. Winner Selection

One (1) winner will be selected each month in a random drawing from all eligible entries received during the Contest Period.

The drawing will be conducted within five (5) business days after the end of the Contest Period.

The odds of winning depend on the total number of eligible entries received.

5. Prize

Each monthly winner will receive a prize as determined by the Sponsor (e.g., a \$100 Visa gift card).

Prize specifics are subject to availability and Sponsor's discretion. The prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or other alternatives. Sponsor reserves the right to substitute a prize of equal or greater value if the advertised prize becomes unavailable.

6. Winner Notification

The potential winner will be notified by direct message via the platform used to enter (e.g., Facebook or the email associated with a Google Review) and/or by phone using the customer contact information on file within five (5) business days of selection.

The winner must respond within seven (7) days of notification. If the winner does not respond within the timeframe or is disqualified for any reason, an alternate winner may be selected.

7. License and Publicity

By entering, participants grant Sponsor a non-exclusive, royalty-free, perpetual, and worldwide license to use, display, publish, and reproduce their entry content (including photos and written statements) for promotional purposes, without further compensation or notice, except where prohibited by law.

8. Limitation of Liability

By participating, entrants agree to release and hold harmless the Sponsor and its agents, affiliates, and employees from and against any and all liability, loss, or damage arising from or in connection with the Contest or the acceptance, possession, or use of any prize.

Sponsor is not responsible for:

- Technical errors;
 - Lost, late, or incomplete entries;
 - Internet or platform outages or malfunctions.

This Contest is governed by the laws of the Commonwealth of Pennsylvania, without regard to its conflict of laws principles.

Personal information collected from participants will be used solely for the purposes of administering this Contest and will be handled in accordance with Sponsor's privacy policy.

11. Miscellaneous

Sponsor reserves the right to disqualify any individual found to be tampering with the entry process or otherwise violating these Rules.
